The Team understands and agrees to the following terms and conditions:

1. **The Team** will be provided with a reserved space for their own trailer/tent on asphalt.
2. **St Ann Catholic Church** will award trophies to 1st-6th place teams and a plaque for the best team area, Sauce 1st-3rd, Boston Butt, Anything But, Mystery Meat and Happy Hour Drink 1st-3rd. In addition, the 1st place team in the Rib Competition will receive a **FREE** rib entry into next year’s contest.
3. **The Team** must provide his/her own equipment, set-up, and staff and assumes all responsibility and liability for, and hereby warrants, compliance with all applicable health and safety regulations. Further, The Team agrees to send a representative to a meeting of all participants for a discussion and review of all rules pertaining to the contest at a time and date to be determined.
4. Set-up will take place on Friday, April 23rd after 11:30 a.m. and must be completed by 5:00 p.m. Please remember that the BBQ will be held on asphalt. All set-ups must be taken down and removed and Team area cleaned on Sunday, April 25th by 2:00 p.m.
5. The Block Party will be held “rain or shine” and no refunds will be made on account of weather.
6. If **St. Ann Catholic Church** cancels the event; the entry fee will be fully refunded.
7. **St. Ann Catholic Church** reserves the right to cancel the event at any time.
8. **St. Ann Catholic Church** reserves the right to deny admission to any individual, including members and guest of **The Team**, if in the sole opinion of event organizers that the individual is engaged in, or poses the threat of disruptive or disorderly activity or conduct.
9. **The Team** is prohibited from selling anything
10. **The Team** agrees to defend, protect, indemnify and hold harmless **St. Ann Catholic Church** and the **Diocese of Memphis** against and from any and all claims arising from the negligence of the Council or any of their participants, agents, family members, officers, volunteers, helpers, partners, organizational members or associates which arise out of the above named activity and use at **St Ann Catholic Church**.
11. **The Team** agrees to protect, defend, hold harmless and fully indemnify **St. Ann Catholic Church** and the **Diocese of Memphis** for any claim or cause of action whatsoever arising out of the above mentioned activity and use which takes place on the dates indicated above that is brought against **St. Ann Catholic Church** or the **Diocese of Memphis** by **The Team** or their family members whether such claim arises from the alleged negligence of **St. Ann Catholic Church** or the **Diocese of Memphis**, its employees or agents or the negligence of **The Team**.
